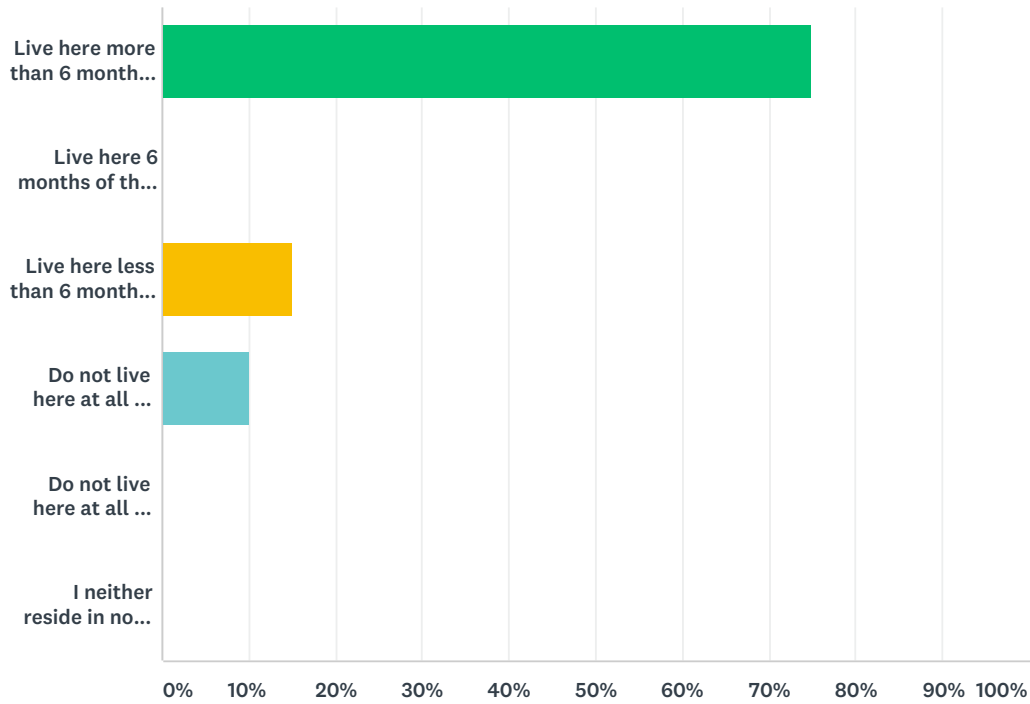


Q1 Which best describes your South Branch Township residency status?

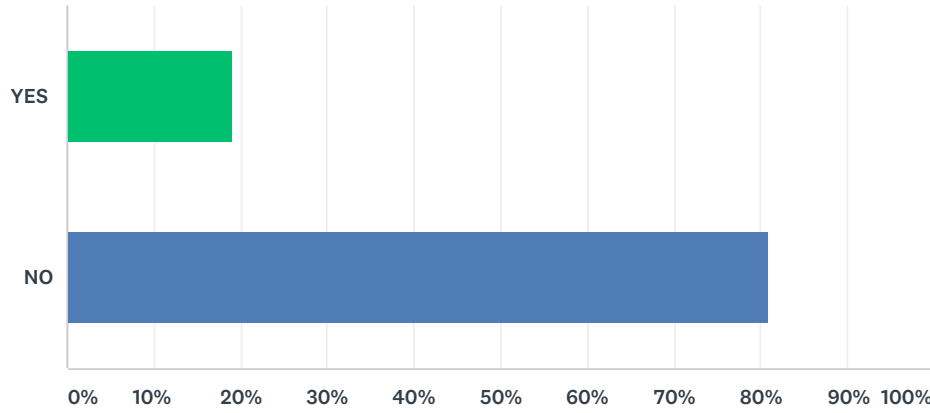

Q2 Do you currently have a Medical Marijuana Card?

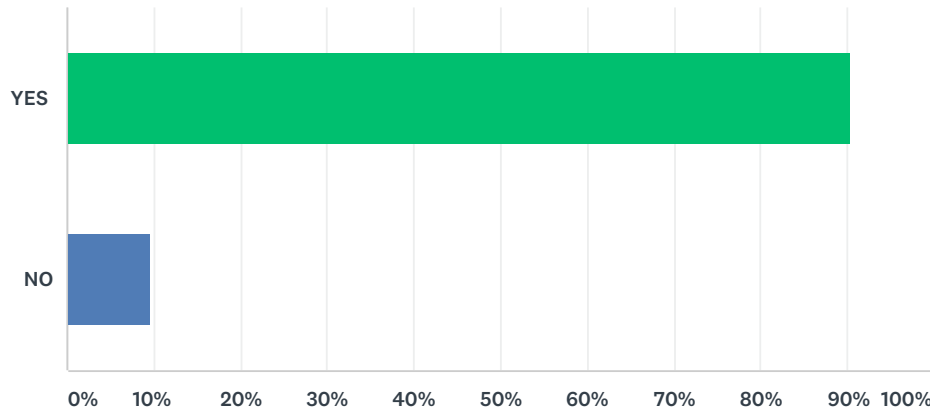

Q3 Do you believe there are medical benefits from using Marijuana?

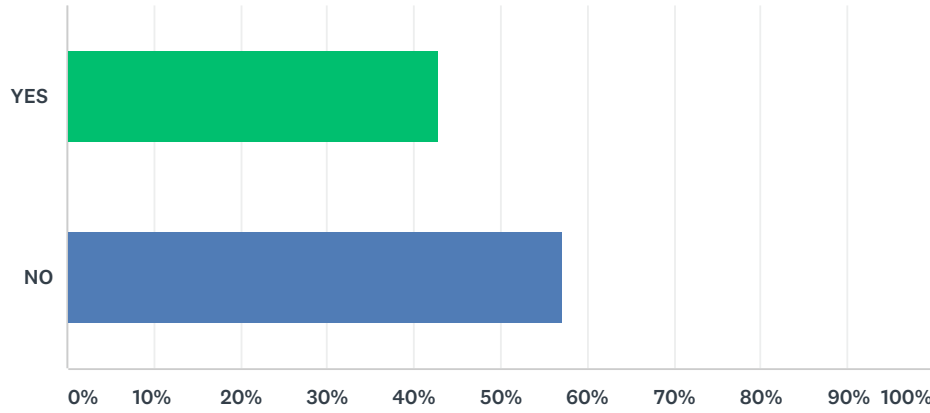

Q4 Should Marijuana Growers be permitted in South Branch Township?

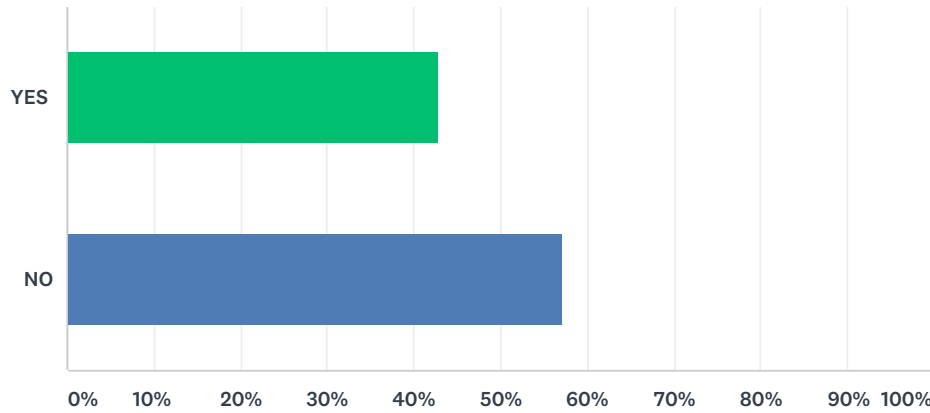

Q5 Should Marijuana Processors be permitted in South Branch Township?

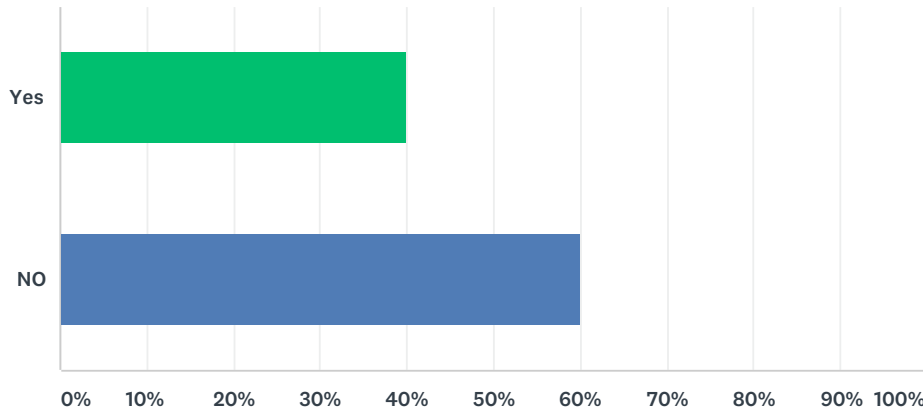

Q6 Should Marijuana Provisioning Centers be permitted in South Branch Township?

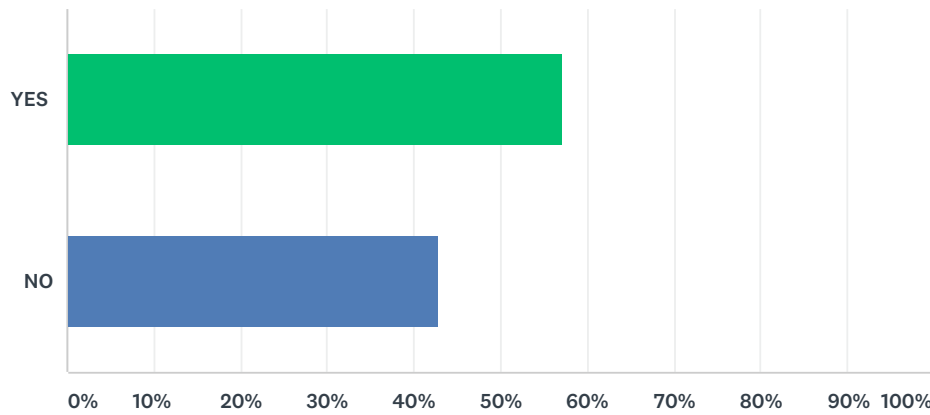

Q7 Should Marijuana Safety and Compliance Facilities be permitted in South Branch Township?

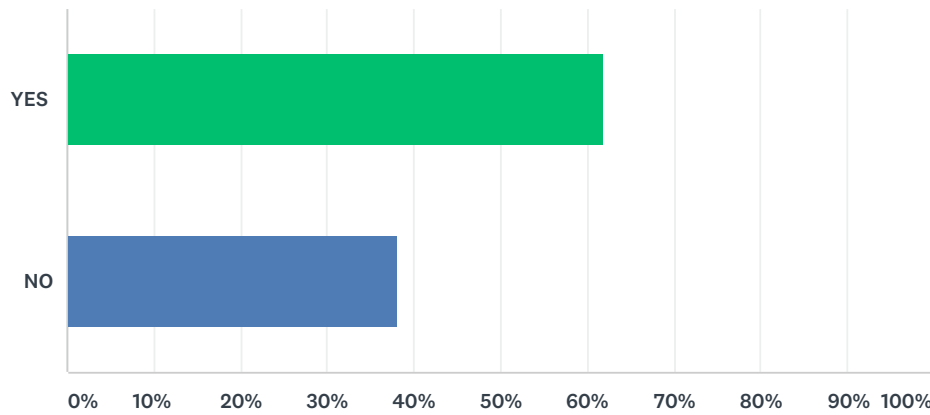

Q8 Should Marijuana Secure Transporters be permitted in South Branch Township?

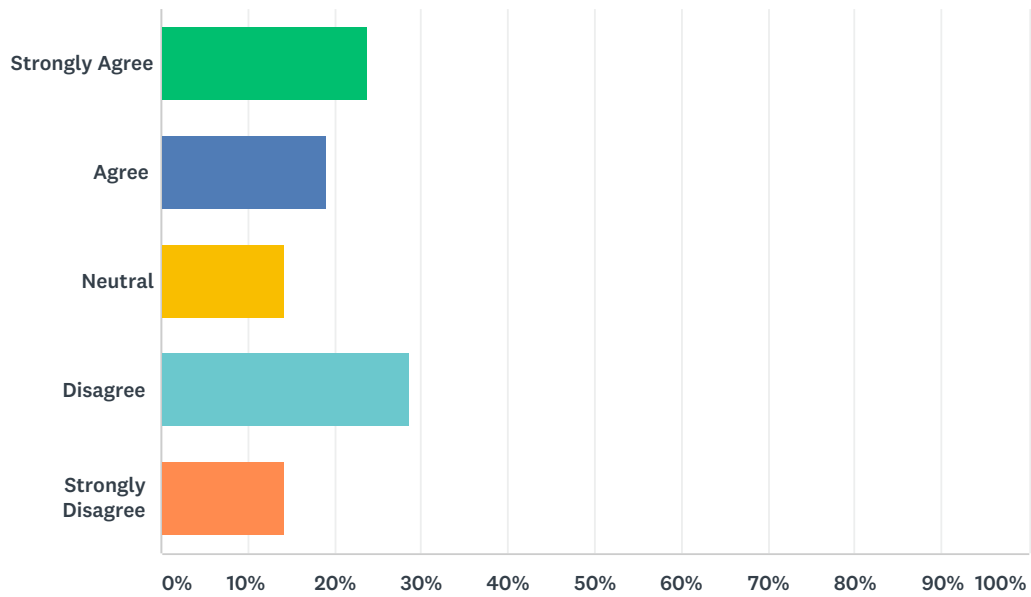

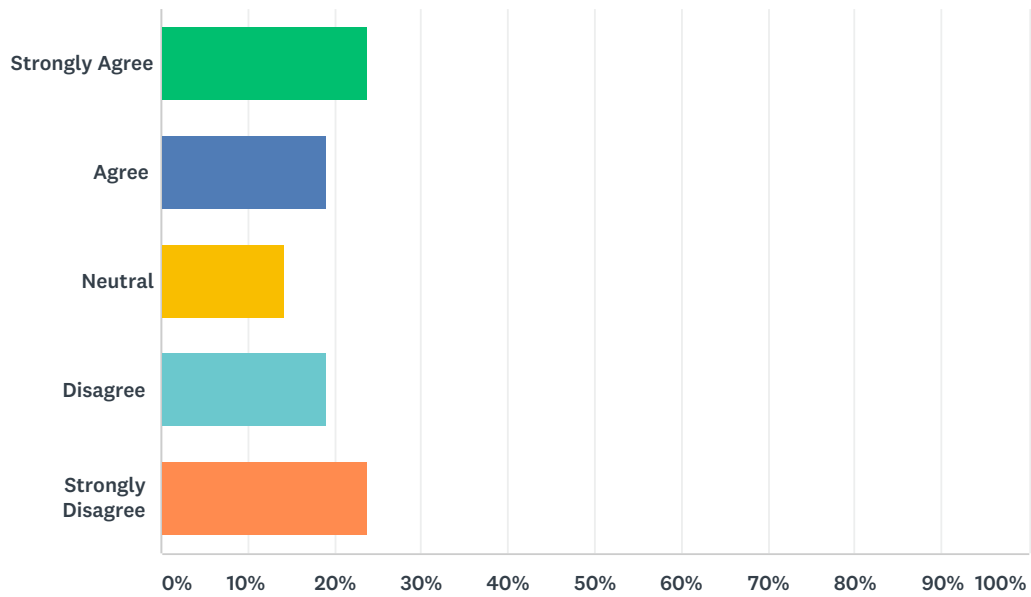
